



## INFORMATION FOR VISITORS

Ladies and gentlemen,

Welcome to our region. Since 1<sup>st</sup>, January 2018, we request that hosts collect the genuine attendance tourist tax ('taxe de séjour au réel') on our behalf. The tax is applicable from 1st January to 31 December. Furthermore, the regional and departmental councils of Aude and Pyrénées-Orientales have introduced an additional 10% tax on top of the tourist tax collected. From 1<sup>st</sup> January 2024, the Occitanie region is also implementing a 34% additional tax to go towards the company managing the new Montpellier-Perpignan rail line.

Through the above taxes, you are contributing to the development of tourism in our region, for which we are truly grateful.

Monies collected through the tourist tax are paid to the EPIC Office de tourisme Corbières Salanque, after deduction of the additional taxes.

(4) Unrated accommodation or accommodation with rating pending are taxed within the limit of the maximum price endorsed by the Communauté de Communes, with the additional taxes (departmental and regional) added on top.

### Exemptions (upon production of supporting documents)

- Minors ;
- Contracted seasonal workers employed within the area of the Communauté de Communes;
- Persons staying in emergency accommodation or who are in temporary rehousing,
- Persons staying in non-commercial accommodation (free accommodation)
